Subject: Complaint

Dear Sir,

I am writing to you in order to report dissatisfaction with response I am encountering with the Access to information and Privacy Department.

1. On or around Oct. 25th, 2012 I made a request under the provisions of the freedom of info to get a copy of a "Minutes of Settlement".
2. After around 3 months AECL sent me some documents without including the main item of my request namely, the involved "Minutes of Settlement". There was neither mentioning nor explanation provided regarding that missing item.
3. On or around Feb. 19, 2013 I wrote an Email message to Ms. Isabelle Verdon (copy enclosed) advising her that I did **not** receive that document i.e. the minutes and requesting her to advise me on the status of my request for that item.
4. On Feb. 19, 2013, Ms. Verdon advised me by Email that AECL does **not** have a copy of the Minutes (copy enclosed).
5. On March 4th, 2013 I wrote back to Ms. Verdon (copy of my email is enclosed) trying to explain to her that AECL has to have a copy of the minutes. I provided her with a detailed explanation as to why the claim that AECL does not have a copy of the settlement is in my opinion totally unfounded. Obviously I was hoping that my reasoning and logic may convince and motivate her to go around the organization to locate the requested document for me.
6. I also had to send her another Email reminder of my request on March 25, 2013 (copy attached).
7. On March 27th, 2013, Ms. Verdon responded with an Email message (copy enclosed) indicating that she cannot help me with my questions. Apparently she ignored the fact that I was not trying to get answers from her regarding my questions. I was mainly seeking her assistance to get a copy of the minutes.
7. I have no choice but to complain to you about the delays and deliberate stone walling of my request which I am making according to the law.


8. I also wish to seek your assistance to provide me with a copy of the minutes based on the following facts which I obtained from AECL own correspondence:

(a) AECL legal department was fully involved in this case from the very beginning. According to one of the documents I had on hand Mr. Gregory Soyer – AECL legal counsel was involved.

(b) According to further confirmed information, AECL legal counsel **signed** the minutes on behalf of the corporation. It could be either Mr. G. Sayer or another member of AECL legal counsel. I am not sure yet about the name.

In conclusion I do take this opportunity to report my complaint to you and to request your assistance to provide me with a copy of the requested minutes from AECL legal department at your very earliest convenience.
